## **PEDAGOGICAL CONDITIONS OF USING THE CLUSTER METHOD IN RAISING CHILDREN IN THE FAMILY**

### **Abstract**

The article considers the use of a cluster (collaborative) method of raising children as harmoniously developed people in a family environment.

### **Introduction**

It is known that in order to further increase the role and participation of the family in the development of society after the national independence of the Republic of Uzbekistan, to strengthen and consistently provide state support for the legal, social, economic, spiritual and moral interests and well-being of families. The year was declared the Year of the Family. On this basis, comprehensive state programs have been developed to ensure the interests of the family. The Republican Scientific and Practical Center "Family" was established. Also, the "Family Code" of the Republic of Uzbekistan on the legal regulation of family life was adopted on April 30, 1998.

The clear goal of radically reforming the system of continuing education also requires the education of young people studying in educational institutions in accordance with the requirements of society. The attention paid by President Shavkat Miromonovich Mirziyoyev to the education of young people, the decrees "On the establishment of the Ministry of Family and Mahalla Support" fully confirm our opinion.

At the same time, parents are not satisfied with the work they do in the field of child rearing in families. Their cooperation with educational institutions is in poor condition. Studies show that parents, especially fathers, do not attend the schools where their children attend even once during the school year. The fact that there are many shortcomings in the upbringing of a child worries us educators. We ask you to take action against an employee who is negligent in the upbringing of his child within the scope of his authority. After all, the situation demands that we all have a responsibility to bring up the younger generation as harmoniously developed people. " Or, conversely, "We are pleased to announce that the child of the employee (name) of the organization you lead will study at our school, and we are pleased to note that your employee is making great strides in raising their children to be well-rounded people. Her children are setting an example to their peers with excellent grades and exemplary behavior. Given its positive results in the upbringing of children, we ask you to provide moral and material encouragement at the level of your authority and ability. "

In this regard, we would like to create a system between the school and the community and organizations, so that the community could act as a bridge between the school and the organization. It is desirable that the school be the initiator of this. It is only beneficial to address the heads of organizations and enterprises with a notice in the name of a common goal. It would be appropriate to set up a parent board at the establishment because the child has exemplary behavior and excellent grades, or has a disability in upbringing and is not mastering the sciences. Organizational leaders can also influence parents at the end of the year by expressing a positive or negative attitude to the achievements and shortcomings in the upbringing of their children. Even when financial incentives are not available, spiritual incentives are always available. Even giving exemplary parents extra vacations, we think, will only benefit from organizing rewards. You see, our common work is to bring up real helpers in educating the next generation to be harmonious people. We are confident that this will give its effective results.

It can be concluded that in the current process of globalization, only society will benefit from conducting scientific and practical research and putting it into practice in order to effectively use the opportunities of the "Innovative Cluster of Pedagogical Education" in order to pay serious attention to children's education.
